PROBATIONARY/ASSOCIATE MEMBERSHIP APPLICATION FORM: PART ONE

Declaration: Firearms Act 1968, Section 21 (as amended).

Please read and if satisfied complete the declaration.

Prior to shooting, or before involvement in any Southend on sea Rifle and Pistol Club (“SRPC”) range activities **All** prospective members, visitors, and guests of the SRPC must sign a declaration stating that they are not prohibited from having a firearm or ammunition in their possession by virtue of this section of the Act.

(1) A person who has been sentenced to preventive detention, or to imprisonment or to corrective training or received a suspended sentence for a term of three years or more, or who has been sentenced to be detained for such a term in a young offenders institution in Scotland, shall not at any time have a firearm or ammunition in his possession.

(2) A person who has been sentenced to Borstal training, to corrective training for less than three years or to imprisonment or received a suspended sentence for a term of three months or more but less than three years, or who has been sentenced to be detained for such term in a detention centre or in a young offenders institution in Scotland, shall not at any time before the expiration of the period of five years from the date of release have a firearm or ammunition in his possession.

(3) A person who – (a) Is the holder of a licence issued under section 53 of the Children and young persons Act 1933 or section 57 of the children and young persons (Scotland) Act 1937 (which sections provide for the detention of children and young persons convicted of serious crime, but enable them to be discharged on licence by the secretary of state); or (b) Is subject to a recognisance to keep the peace or to be of good behaviour, a condition of which is that he shall not possess, use or carry a firearm, or is subject to a probation order containing a requirement that he shall not possess, use or carry a firearm; or (c) has, in Scotland been ordained to find caution a condition of which is that he shall not possess, use or carry a firearm; shall not, at any time during which he holds the licence or is so subject or has been so ordained, have a firearm or ammunition in his possession.

(4) It is an offence for a person to contravene any of the foregoing provisions of this section.

(5) It is an offence for a person to sell or transfer a firearm or ammunition to, or to repair, test, or prove a firearm or ammunition for, a person whom he knows or reasonable ground for believing to be prohibited by this section from having a firearm or ammunition in his possession.

- any breach of this rule constitutes a criminal offence and the Club's Committee and Officers accept no responsibility if I fail to comply;
- I may not shoot until my application for probationary membership has been accepted by the **SOUTHEND-ON-SEA RIFLE AND PISTOL CLUB**;
- The Club will contact at least one of the provided referees;
- probationary membership, and subsequent membership of the Club, will not be approved if my sole purpose in applying is to have a Home Office approved Club membership to retain my Firearm Certificate, whilst having no intention to fully participate in the Club's activities and competitions, and
- whilst the **SOUTHEND-ON-SEA RIFLE AND PISTOL CLUB** will treat this application as confidential they must, as part of their Home Office approval, notify the (Essex) Police of any applications for membership and of any subsequent changes in membership status.
